

The Common Council of the City of Connersville held their regular meeting on Monday, March 18, 2024, at 7:00 P.M. in the Council Chambers at City Hall.

Councilman Collins led the Pledge of Allegiance and Pastor Eric Hopkins offered invocation before the start of the meeting.

Mayor Chad Frank presided and called the meeting to order with Councilwoman Sharon McQueen, Councilwoman Jenny Barrett, Councilman Tommy Lee Williams Jr., Councilwoman Diana Phillips, Councilman Brian Robb, Councilman Bill Gray, and Councilman Jabin Collins were present. Attorney Geoff Wesling was also present.

Councilman Gray made a motion to approve the minutes of the March 4, 2024, regular meeting; Councilman Rob seconded the motion. All Council members voted "yes."

Clerk Treasurer Rosemary Brown requested approval of **Resolution 2024-04**, a resolution to reimburse One Hundred Fifty and 00/100 dollars (\$150.00) into DOT 234 Vehicle Repair, and **Resolution 2024-05**, a resolution to reimburse One Hundred Fifty and 00/100 dollars (\$150.00) into Police 324 Telephone. Councilwoman Phillips made the motion to approve **Resolution 2024-04 and -05**, Councilwoman McQueen seconded the motion. All Councilmembers voted "yes".

Clerk Treasurer Rosemary Brown requested approval of **Resolution 2024-06**, a resolution to transfer Twenty-Eight Thousand Four Hundred Twenty-Six and 35/100 dollars (\$28,426.35) from 1101 General to 2435 First Aid Non-Reverting, **Resolution 2024-07**, a resolution to transfer Thirty-Two Thousand Nine Hundred Four and 99/100 dollars (\$32,904.99) from 2459 Local Road and Bridge Match to 2458 Community Crossing Grant Fund, **Resolution 2024-08**, a resolution to transfer One Hundred Six Thousand One Hundred Sixty-Four and 00/100 dollars (\$106,164.00) from DOT 444 Other Equipment to 4653 DOT/MVH Non-Reverting, **Resolution 2024-09**, a resolution to transfer Ten Thousand and 00/100 dollars (\$10,000.00) from MVH 444 Other Equipment to 4653 DOT/MVH Non-Reverting, **Resolution 2024-10**, a resolution to transfer Five Thousand and 00/100 dollars (\$5,000.00) from Park 440 Other Equipment to 4652 Park Non-Reverting, **Resolution 2024-11**, a resolution to transfer Two Hundred Eighty Thousand and 00/100 dollars (\$280,000.00) from 2203 MVH Restricted to 4459 Local Matching Fund, and **Resolution 2024-12**, a resolution to transfer One Hundred Nine Thousand and 00/100 dollars (\$109,000.00) from 2202 Local Road & Street to 4459 Local Matching Fund. Councilwoman Phillips made the motion to approve **Resolution 2024-06 through -12**, Councilman Robb seconded the motion. All Councilmembers voted "yes".



Councilman Collins made the motion to reject this ordinance to allow for the Commissioners corrections and these corrections mentioned tonight. Councilwoman seconded the motion. All Councilmembers voted "yes".


